2. Role under the PPWR

The issuing company acts as the **manufacturer of packaging within the meaning of Regulation (EU) 2025/40 (PPWR)**. The specific allocation of roles is defined in the associated technical documentation.

3. Declaration

We hereby declare that the above-listed ColomPac® standard packaging products comply with the applicable requirements of Regulation (EU) 2025/40 (PPWR), insofar as these are applicable to the respective packaging.

4. Applicable legal provisions and requirements

This EU Declaration of Conformity refers to Regulation (EU) 2025/40 on packaging and packaging waste (PPWR).

It confirms that the packaging described above complies with the relevant requirements of the PPWR, insofar as these are applicable to the respective packaging and are specified by delegated acts at the time of preparation, in particular:

- ✓ Article 5: Requirements for substances in packaging: Based on information provided by our suppliers, the materials used comply with the requirements of Article 5 of Regulation (EU) 2025/40. The sum of the concentrations of lead, cadmium, mercury and hexavalent chromium does not exceed the limit of 100 mg/kg. As the packaging is not intended for direct contact with food, PFAS testing is not applicable.
- ✓ Article 6: Recyclability of packaging: Our ColomPac® packaging products are made from paper- and fibre-based materials and are, to the best of our current knowledge and according to established practice, suitable for material recycling through established paper and cardboard recycling streams.
- ✓ Article 7: Minimum recycled content in plastic packaging *(not applicable, as this is not plastic packaging)*
- ✓ Article 8: Bio-based feedstock in plastic packaging *(not applicable, as this is not plastic packaging)*
- ✓ Article 9: Compostability *(not applicable, as the packaging is not designed or marketed as compostable within the meaning of the PPWR)*
- ✓ Article 10: Minimisation of packaging and empty space: The ColomPac® packaging products have been designed according to their intended function and optimized with regard to material usage and volume. The weight, material composition and design of the packaging are aligned with product protection requirements, transport conditions and handling needs.
- ✓ Article 11: Reusability / refill systems *(not applicable, as this is single-use transport packaging without a reuse system)*
- ✓ Articles 12, 13 and 15 – Labelling and Information Requirements: All ColomPac® corrugated board products are marked, where applicable, with **FSC certification labels, product identification, a QR code containing producer information**, and the currently valid **national recycling codes**. Additional information relating to the **product, batch, or production date** is provided through **accompanying documents**, delivery notes, or pallet labels. The harmonized EU labelling requirements under the PPWR will be implemented in due time following the publication of the final implementing acts.

5. Harmonised standards

At the time of preparation, no harmonized standards pursuant to Article 36 PPWR have been published in the Official Journal of the European Union.

The conformity assessment is therefore carried out based on internal assessments and supplier evidence.
